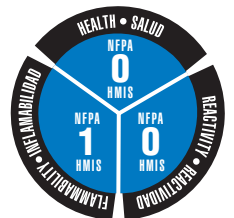

## DIRECTIONS FOR USE:

### MOP-ON CLEANING

1. DILUTE 1 to 2 ounces per gallon (1:128 or 1:64) of cool water.
2. CLEAN: Damp mop the area.
3. DRY: Allow to dry (10 to 15 minutes).

### CARPET CLEANING

1. DILUTE 1 to 2 ounces per gallon (1:128 or 1:64) with the cleaning solution in carpet cleaning extractor.
2. EXTRACT then force dry.

### GENERAL CLEANING

1. DILUTE 1 to 2 ounces per gallon (1:128 or 1:64) of cool water.
2. SPRAY surface. Use only as much as is required. Do not over-wet surface.
3. WIPE surface clean.

### Precautionary Statement

#### Prevention

Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Keep container tightly closed. Ground/bond container and receiving equipment.
